Bio / Admin History: The Townline Mutual Telephone Co. provided telephone service to a rural district immediately north and east of the village of Millet. Its shareholders were all telephone subscribers in the district. It was apparently incorporated in 1950 and was dissolved in 1971, when Alberta Government Telephones began providing service directly to the district.

Custodial History: The fonds was donated with the records of Mullen General Insurance. James R. Mullen was Secretary-Treasurer of the company.

Scope / Content: The fonds includes account books (1950-1970), a bank account book (1951-1962) and receipt books (1951-1970). Some file titles in the inventory were supplied by the archivist.
