Bio / Admin History: The Millet West Mutual Telephone Company Ltd. provided telephone service to a rural district west and south of the village of Millet. Its shareholders were all telephone subscribers in the district. It was incorporated in 1934 and was dissolved in 1972, after Alberta Government Telephones began providing service to the district.

Custodial History: Most of the records in the fonds were donated with the records of Mullen General Insurance. James R. Mullen and his successor Al Hegge were Secretary-Treasurers of the company.

Scope / Content: The fonds includes minutes, correspondence, maps, a certificate of registration of share capital, cash books, account books, bank account books, cheque stubs, cancelled cheques, bank deposit books, and receipt books. Some file titles in the inventory were supplied by the archivist.
