Bio / Admin History: Leslie W. Marr brought a farm at S.W. 15-47-25-W4 in ca. 1904. He married Margaret Bryan Atkins in 1909 and had five children Barbara, William (Bill), Roland, Lois and James Leslie (Jim). Leslie was a municipal councilor and a member of the Hillside School Board. Margaret was the founding member of the Women's Institute and the United Farm Women's Association, as well, she was Secretary Treasurer of the Hillside School District. James Leslie moved back to the farm in 1956 and farmed five quarters of land in partnership with William as the Marr Bros.

Custodial History: The donation of the Marr family to the Millet and District Museum and Archives by James Leslie Marr in 2007.

Scope / Content: The fonds consists of receipt stubs for Hillside area taxes, receipt for Leslie Marr, Alberta Pacific Grain Co. book, contract with Rural Electrification Association, mortgage loan, cream statements, rural fire co-op membership and geophysical operations permit.
